A. General

B. INFORMATION

- 4. The information you have provided us with in the registration form, including your name, company, position, country, telephone number and email (the "**contact Information**"), will be used by the Organizers for the following purposes:
 - a. To create and issue your conference badge, with your own QR code as detailed in section C (the "**badge**").
 - b. To contact you if necessary.
 - c. To make statistical analysis of the attendees of the Conference.
- 5. The contact Information will be transferred to the onsite registration company which will create the badge and arrange the onsite registration. The transfer of the contact Information is mandatory and essential to your participation in the Conference. Without the said transfer we will not be able to register you onsite, including register your participation in the Conference, contact you in the event of any problem and issue the necessary badge for your participation in the Conference.
- 6. It is hereby clarified that the very fact of carrying the badge does not constitute an approval to transfer your contact information, via QR code, to any person participating in the Conference. The use of the badge will be done only as specified below.
- 7. We hereby inform you that you have the following rights:
 - a. Right to obtain confirmation as to whether or not personal data concerning you exist, and communication of such data in intelligible.
 - b. Right to be informed:
 - i. of the source of the personal data;
 - ii. of the purposes and methods of the processing;
 - iii. of the logic applied to the processing, if the latter is carried out with the help of electronic means;

- iv. of the identification data concerning data controller, data processors and the representative; and
- v. of the entities or categories of entity to whom or which the personal data may be communicated and who or which may get to know the said data in their capacity as designated representative(s) in the State's territory, data processor(s) or person(s) in charge of the processing.
- c. To obtain updating, rectification or, where interested therein, integration of the data;
- d. To obtain erasure, anonymization or blocking of data that have been processed unlawfully, including data whose retention is unnecessary for the purposes for which they have been collected or subsequently processed;
- e. In such instance, you subject yourself to their communications and privacy policies,.
